#### Marcia Ryan

# **Preparation**

Photocopy the worksheet, one for each group of ten students in the class. Cut apart the cards and shuffle them.

## Answers

Marcia Ryan met Phil Stanley in 1942 in Hawaii. Phil Stanley met John Peterman at Ramsey Accounting and Associates in the 1960s. John Peterman met Tina Marie Togger in 1979 during the Rocky Mountain forest fires.

Tina Marie Togger met Steve Whitman at Chugwater High School in the 1980s.

Steve Whitman met Miriam Rodriguez in Chicago in the 1990s.

Miriam Rodriguez met Nancy Williams Martinez in Villa Coronado between 1982 and 1984.

Nancy Williams Martinez met Tim Riles at the Michaels & Riles law firm in the 1990s.

Tim Riles met Julia Silvers at the University of Colorado in Boulder several years ago.

Julia Silvers met Tom Lubbock while working for the Boulder police department.

Tom Lubbock met Marcia Ryan recently at the New Home Orphanage in Connecticut.

# **Procedure**

- 1 Ask students to form groups of ten students. If you have extra students, ask them to work in pairs with another student within the group. Extra students can also form a smaller group. In this case, give each student several identities, making sure that the group has all ten identities in hand when the activity begins.
- 2 Explain the task.
  - Students should imagine they are at an international conference in St. Louis, Missouri.
  - The students all have different identities and personal histories which they will read about on the cards you give them. They're at the opening cocktail party and each of them recognizes two people.
  - The students' objective is to ask and answer questions until they discover where they've met two of the people before.
  - The students should not let other students read their cards.
- 3 Shuffle the sets of cards and give one set to each group.
- 4 Ask students to begin the activity. They should feel free to stand up and change seats as necessary to talk to different members of their group.
- 5 Move around the classroom giving help as needed.
- 6 When all students have found both of the people they have met before, stop the activity and check their answers.

# **Option**

Ask students to work in pairs to read the identities and discover who has met whom before. They should then place the ten cards in a circle on their desks to show the chain of connections and underline the phrase in each identity that shows the link between people.
