TEACHER'S NOTES

Lesson Focus: Drafting contracts

Level: Intermediate and above

Class size: Small groups, preferably legal or business professionals.

Time: 90 minutes

Note: This lesson would be most appropriate at the start of a new course to set out expectations and objectives in a formal way. The contract can later be referred to to clarify each party's responsibilities in the learning process.

Procedure

- write They ______ the contract on the board. Give students two minutes in pairs to think of as many verbs as possible that could complete the sentence. Make a list of all the ideas on the board and focus on any verbs with similar meanings (e.g. modify, change). Ask the students if the verbs on the board are common English or legal English.
- 2 Give each student a copy of Worksheet 1. Put students in pairs and ask them to read the sentences in Exercise 1 and replace the underlined legal verbs with their common-English equivalents. After five minutes, check answers together. (Answers: 1c, 2 a, 3d, 4a, 5b).
- 3 Exercise 2. In pairs students match the similar verbs in the two columns. (Answers: to draft, to draw up, to fulfil, to honour, to amend, to modify, to nullify, to make void, to breach, to infringe.)
- 4 Tell the students that you are going to draft a contract together to set out the responsibilities and expectations in the English classes. Answer the first question together (The parties are the Teacher on one side and the Student/s on the other). Put the students in pairs or small groups and tell them to think about the other questions and write the ideas they agree upon in the spaces provided. After 7-8 minutes, bring groups together and go through their ideas on the board. Encourage discussion using phrases such as:

That's too strict.

That would be hard to prove.

Who would decide if the student had not spoken enough?

That definition is not clear enough.

Make sure you are involved in the negotiation of clauses to explain why some of the clauses they do not like could be very useful to their learning.

- Give each student a copy of Worksheet 2. In different groups, give the students five minutes to think of possible penalty clauses following the example given (*If..., he will...*). With more advanced legal classes, you could also highlight the use of should to mean if in contracts (e.g. *Should the teacher fail to correct the homework, she will...*). Students read their ideas out to the class.
- 6 Draw students' attention to the list of other suggested clauses and, in pairs, give them 7-8 minutes to decide which of them they would agree to.
- Pring the class together to discuss which of all the clauses (the suggested clauses and the students' own) they are going to include in the contract. Give the class one copy of the blank contract. Complete the head of the contract together (Date, People present, Location, Teacher's name, Students' names, Day, Time and Length of class, Start date of course). Nominate one student to draft the contract whilst the other students dictate clauses. When finished, all students and the teacher sign the contract. Photocopy and give each student a copy. Refer to the contract in future classes and apply the penalty clauses when appropriate especially when it is you that breaches a condition of contract!
